The company process factory employs 25 workers, on a permanent employment basis.

Factory workers are paid regulated monthly salaries, overtime and bonuses and are also entitled to other benefits like safe work place, clean canteen facilities, clean toilets, clean drinking water, health and maternity benefits etc.

Worker livelihood enhancement and upliftment schemes were not checked at this inspection.

#### **Emission Control and GHG gas absorption:**

Farms are under 100% organic production methods and as resalt the fields do not emit methane gas which normally arises from chemical use. In the factory diesel used for boiling the sap in the boilers. The smoke emission is controlled by passing the smoke through the chimneys to height of about 40ft or more above the roof.
